## what's going on in the lrc's

### Australian Law Reform Commission (ALRC)

- *Contempt of Court*. WIH. RP an 'Improper Pressure on Parties to Court Proceedings' issued October 1986 and RP on 'Prejudicial Publicity and the Courts' issued November 1986. Draft Report being finalised, due early 1987.
- *Sentencing*. WIH. 3 DP's in preparation.
- *Debt Recovery*. WIH. Report finalised, due early 1987.
- *Matrimonial Property Law*. WIH. Report in preparation, due to be tabled Autumn session 1987.
- *Class Actions*. WIH. North American consultant, Mr Andrew Roman, completed his ALRC consultancy in January 1987 (see [1986] *Reform 208*). Draft report being prepared, due mid 1987.
- *Insolvency*. Consultants meetings were held on 31 October and 12 December 1986. WP's on 'Directors Liability', 'Insolvency Administrators', 'Property Available for Distribution', 'Discharge', 'Administration of an Insolvency' and 'Insolvency Offences' were discussed. This completed the series of Working Papers to be prepared on the Reference. A consultants meeting to consider draft legislation which will form the basis of a DP will be held in March. The Discussion Paper should be available in May 1987.
- *Privacy/Sentencing: Expungement of Criminal Records*. WIH.
- *Admiralty Jurisdiction*. Civil Jurisdiction Report tabled 2 December 1986. Report on Prize and Criminal aspects of the reference due mid 1987.
- *Service and Execution*. WIH. on report.
- *Occupiers Liability*. WIH. DP has been examined by the consultants and their views will be incorporated in final draft. Due for distribution early 1987.
- *Evidence*. Report awaiting printing, due early 1987.
- *Community Law Reform in the ACT – Loss of Consortium*. Report tabled 23 October 1986.
