MEETINGS

Committee meetings are held at 12.15pm on the first Wed-nesday of each month. General meetings will be normally held on the second Wednesday of each month. Currently the venue for all meetings is the lecture theatre belonging to the Legal Workshop in Building F, Fellows Road, Australian National University between the Law Faculty and the Menzies Library. These meetings will be at 12.15pm, unless otherwise notified. They typically last from 1 hour to 1.5 hours.

MAY MEETING: HIGH COURT REGISTRY

On 8 May, Chris Smyth, Registry office manager at the High Court, gave details of the Court's new records management system to a well attended meeting. The Court handles about 400 cases each year and up to 50 enquiries per day are made by parties, practitioners and others to the Registry. A manual index - on cards - had been kept for many years and it was decided to test the capabilities of a small computer system to provide a docketing system which could also provide other information - for planning and statistical purposes - when required. Chris gave details of the hardware and software used by the Court (DEC Rainbow 100+, dbaseII and customised programs) and raised some of the problems so far experienced. Overall, the system is capable of meeting the aims set for it. The number of informed questions at the close of the address showed the level of interest generated.

EXTRACTS FROM PRESIDENT'S REPORT 1984/85: Peter Harris

The Society for Computers and the LAW (ACT) Inc originated as a result of widespread interest shown as a result of displays during Information Technology Week in August 1983. Regular meetings begin in March 1984 and the Society was incorporated on the 17th October 1984. The Society has a varied membership comprising Solicitors, Barristers, Computer Specialists, Legal Information Specialists and Academic Lawyers.

Total membership is now 55 and amongst its members the Society is proud to include the High Court of Australia, Parliamentary Library, the Attorney-General's Department and many of the prominent legal firms in the Australian Capital Territory.

Discounts have been arranged with local suppliers of consumables for office computers/word processors. The Society is also creating a library of relevant literature and public domain software.

To a large extent, the Society has an educational role in the legal community.
