CONTENT QUOTAS MET BY MOST TV LICENSEES IN 2005

All but one of the metropolitan commercial television licensees reported that they met the Australian transmission quota and content requirements of the Australian Content Standard and Children's Television Standards in 2005. The exception was QTQ Brisbane, which fell short of the preschool program quota, broadcasting only 129.5 hours rather than 130

All metropolitan commercial network licensees exceeded the minimum 55 per cent Australian transmission quota in 2005, with Nine Network licensees achieving more than 60 per cent in the three metropolitan markets of Sydney, Melbourne and Brisbane. Network Ten licensees had nearly 60 per cent in the five mainland state capital cities and the Seven Network had just over 55 per cent in each of these markets.

The minimum annual points requirement for first release Australian content is 250. During 2005, all Seven Network licensees increased their annual score for first release Australian drama programs, each scoring 430 points. Network Ten licensees scored 285 points in all markets and Nine Network licensees

scored between 275 and 282 points.

The minimum requirement for first release Australian drama programs over a three-year period is 830 points. During the three years from 2002 to 2004, the Seven Network

between 831 and 832 points in their three metropolitan markets.

The requirement to broadcast at least 96 hours of first release Australian children's drama over three years began in 2003, with the to ensure all commercial networks continue to fulfil the requirements for first release Australian drama programs over the current three-year period.

- a licensee must broadcast at least 130 hours of first release Australian C programs (50 per cent of total C requirement) each year a licensee must broadcast at least 25 hours of first release Australian children's drama programs
- each year (annual requirement C drama)
- a licensee must broadcast in each three-year period at least 96 hours of first release Australian children's drama (three-year requirement – C drama)
 a licensee must broadcast each year in the C band at least eight hours of repeat Australian C drama programs and a licensee must broadcast at least 130 hours of Australian pre-school programs each year.
