Changes cabling provider rules

In December 2005, ACMA approved changes to the rules that regulate customer cabling work and set the standard for the cabling industry.

In summary, the changes:

- establish a practically achievable compliance regime for the termination of cabling in building control services equipment
- tighten the certification requirements for registered cablers supervising unregistered cablers; and
- exempt certain types of minor cabling work from the obligation to be certified.

The changes to the Telecommunications Cabling Provider Rules 2000 follow wide-ranging industry consultation by ACMA and are designed to improve their operation.

The review was undertaken to ensure that the rules

keep pace with changes in the industry, to explore opportunities for extending self-regulation and to examine issues that have been raised by industry since the rules were introduced in October 2000.

The cabling provider rules apply to individuals performing customer cabling in the communications, security, fire and data sectors. Apart from limited exceptions, the rules cover all cabling work connected to a telecommunications network, or intended to be.

All cablers are required to perform and supervise cabling work according to the Australian Standard - Installation Requirements for Customer Cabling (Wiring Rules) (AS/ ACIF S009:2001). Cablers are also required to register with one of five accredited registrars as part of an industry-managed

national cabling registration scheme.

ACMA monitors compliance with the rules by, for example, a contracted audit program and the investigation of individual complaints. ACMA has commissioned Gibson Quai - AAS to conduct the cabling audit program on its behalf in 2005-06.

CARRIAGE SERVICE PROVIDER ANNUAL NUMBERING CHARGES

Sunday, 2 April will be the census date for the 2006 annual numbering charges applying to telephone numbers held by carriage service providers.

ACMA administers the collection of the charges under the Telecommunications (Numbering Charges) Act 1997, the Telecommunications Act 1997 and determinations made by ACMA under those Acts.

Each year, the determinations set the census date and the amount of the charge, the types of numbers exempted, when payment is due and late payment penalty provisions. The terms for the 2006 payment date, penalty rate and exemptions remain unchanged from last year.

NUMBERS

The numbers exempted from charges on the census date are detailed on the ACMA website.

Carriage service providers can surrender numbers they no longer require until the surrender embargo begins on 10 March 2006.

CHARGES

The charge for a particular number depends on its length and the type of service provided. There is a standard charge for a 10-digit number, which increases by a factor of 10 for each digit reduction in the number's length.

The standard charge for 2006 will be determined after the census date. The 2005 charge was \$0.94609328. This means that 10-digit numbers such as mobile numbers were

charged at approximately \$0.95 each, nine digit numbers at \$9.50, eight digit numbers at \$95.00, and so on.

The maximum charge on any one number is \$100,000. Some numbers, such as telex numbers, are charged at a discounted rate.
