

Carrier fined for failing to lodge eligible revenue return

On 18 January 2006 Chariot Limited was fined \$10,000 in the Adelaide Magistrates Court for committing an offence under the Telecommunications (Consumer Protection and Service Standards) Act 1999. Chariot failed to lodge an eligible revenue return as required by the Act.

'The universal service obligation is an important way of ensuring that everyone in Australia has reasonable access to standard telephone services,' said Chris Chapman, ACMA Chairman. 'This court decision highlights that ACMA is comfortable with taking action in appropriate circumstances against carriers that fail to meet their regulatory responsibilities.'

All licensed carriers are required to submit an eligible revenue return for each financial year. Eligible revenue returns are used to help determine how much each carrier contributes to the cost of the universal service obligation (USO). The USO ensures that all Australians regardless of where they live have reasonable access to basic telephone services and payphones. The USO is provided by Telstra but funded by all carriers. If a carrier fails to lodge an eligible revenue return, ACMA may make an estimate of the carrier's eligible revenue.

Under section 23C of the Act it is an offence not to submit an eligible revenue return form within 90 days of the end of the financial year.
