#### United Kingdom: U-18s: Child soldiers at risk

Published by Amnesty International, the report calls for the UK government to stop recruiting growing numbers of under-18s into the armed forces. It shows that the UK government's policy does not stop at recruitment but includes the deployment of children in armed conflict. Amnesty International urges the UK to ratify the new Optional Protocol as soon as possible without any reservation; to adopt a policy of not deploying under-18s to situations of armed conflict or in any other peace-keeping or similar mission; and to implement a policy of maintaining the civilian status of under-18s during the training.
