Tables of ten delegates each were asked to rank fourteen issues for their importance, and to give priorities to the five issues which they thought were most important.

Here are the top five priorities.

1st

Rationalisation of contractual

relationships, especially the allocation of risk between the parties

Equal 2nd

More effective Management practices, including project management, design of work packages and selection of

subcontractors.

Equal 2nd

Improved training for management and

workers.

4th

Better project definition, including

more complete documentation.

5th

Improved technical efficiency and

capability, including a significant lift in research and development effort.

Four other issues were identified as requiring further work.

6th

More efficient and flexible work

practices and arrangements.

7th

Improvements in safety standards and

working environment.

**Equal 8th** 

Improved export performance.

Equal 8th

Improved security and continuity of

employment for workers.

This list has no magic to it, but is a good reflection of the immediate concerns of the two hundred delegates who participated in the session, and provides the incoming ACIC members with a useful rule of thumb to gauge industry's preferences.
