

Chairman's report on Branch activities for the year July 1977 — June 1978.

Distinguished guests, Members of the Council, Ladies and Gentlemen.

The year just concluded although starting somewhat slowly has been a very active one. As always happens when the Biennial Conference of the Council is held, August and September are usually lost in that year as far as Branch activities are concerned. In the past your committees have felt it inappropriate to commit the incoming committee in any way. Personally I do not agree and I would hope that in future the outgoing committee will plan for the first two months of the new year. It takes time for a new committee to settle down and perhaps more importantly to arrange programmes and at the same time give sufficient notice to the membership of meetings.

Your Committee this year chose for its theme "Juvenile Justice" and this has proved extremely successful. I wish to pay a personal tribute to the Committee and in particular Ms Cheryl McKinna and Ms Sybil Hardie, who have worked extremely hard on this year's activities. In saying this, I am not detracting from the contribution of the other members of the Committee but it is fair to say that Ms McKinna our Secretary and Ms Hardie contributed much in time and effort to make a success of this year.

Your incoming Committee will, I feel sure, contribute regularly, but I would hope that many individuals from our Branch will also make worthwhile contributions.

Reference was made in last year's Annual Report to the success of our publication on shop stealing and it is pleasing to advise that interest has continued and our publication is still being sought from variety of quarters. I am hopeful that the publication of the papers presented this year will similarly be sought.

It is with deep regret that we record the passing of Mr A. R. Whatmore who in December last year died suddenly. Mr Whatmore was very active in the correctional field and later also the welfare field for many years and became the first Director-General of the then Social Welfare Branch of the Chief Secretary 's Department in 1960. He was also the first Chairman of our Committee when it was formed on 25th October, 1971 and remained as Chairman for two years. His contribution to our activities at a time when we were trying to establish ourselves was a very real one. We extend sincere condolences to Mrs Whatmore and her son.

Our immediate past Chairman, Mr R. M. Braybrook, O.St.J., Q.P.M., J.P., retired from the Victorian Police Force on May 30th, 1977, and I would like to take the opportunity of thanking Mr Braybrook for his very considerable support. He became our Deputy Chairman when our Branch was formed in 1971 and Chairman in July 1973. Your Committee has missed him very much. It is our earnest

hope that Ron has a long and happy retirement.

Prior to the last Biennial Conference in Sydney, your Committee supported the Fairlea Women's Prison Council with the following resolution "that a sub-committee be set up by the Australian Crime Prevention Council to conduct a survey in all States and Territories of Australia to ascertain whether women prisoners have available to them, rights, opportunities, facilities and standards of conditions as set down in the United Nations standard minimum rules". This resolution was adopted and the convener of this sub-committee is Dame Phyllis Frost.

Dame Phyllis and a small group of people have worked very hard on the preparation of a questionnaire which is now being circulated throughout Australia. It is hoped that the result of this survey will be part of a contribution to be made at the next United Nations Congress on the Prevention of Crime and the Treatment of Offenders to be held in Sydney in 1980. It is hoped of course, that where there are deficiencies or shortcomings these will be remedied before 1980.

During this year, your Committee has met on 10 separate occasions and of course in addition there has been frequent telephone

contact and informal meetings.

After giving the required 28 days notice the following motion to amend the Branch Constitution was put to the membership at a General Meeting held on February 6th, 1978.

"Such additional members (but not exceeding two) whom the Officers shall co-opt at their own discretion onto the Branch Committee as soon as practicable after their election so as to ensure that the major disciplines or fields covered by the objects of the Council are represented on the Branch Committee. Such co-opted members shall be afforded full voting rights. The co-optees shall be financial members at the time of their co-option".

This was accepted by the meeting.

Your Committee felt that where a major discipline was not represented that this should be remedied if at all possible.

The year just concluded, our seventh as a Branch has, I think you will agree, been a good one and the future can be viewed with

considerable optimism.

Resulting from the tenor of speeches made to those attending by Mr Whitrod and Mr Bevan about the dearth of non-professionals and volunteers interested in the Branch in the Capital Territory, Mr lan Robertson undertook to prepare a paper on the breadth and depth of volunteer effort active in Canberra and to present it at public meeting at the Institute on the evening of 21st August at 8 pm. All thirty volunteer agencies will be contacted and invited to the meeting.

During the months separating the last Executive Meeting and the recent A.C.T. Branch Annual General Meeting the Branch has met monthly at lunch hours and conducted two evening public lectures on (1) Crime and the Aged by a Visiting Professor in Sociology at the A.N.U., Professor A. The aim of the Branch is now to make every effort to recall volunteer and the general public to a concern for and interest in crime prevention and try to involve such members in its executive management, as a first move to restore the Australian Crime Prevention Council as something of a pressure group on anomalies and

short-comings in the Criminal Justice System.

HONORARY TREASURER'S REPORT on the period 1 JUL 77 to 30 JUN 78

1. Members may recall that at the last Annual General Meeting I tendered two series of statements. One was for the period from the formation of the Branch on 23 July 1974, till the conclusion of the period during which the Branch was dormant, 31 March 1977. The other was for the short period during which the resurrected Branch had functioned, 1 April 1977 to 30 June 1977.

2. Annexed to both series of statements were schedules in which I attempted to reconstruct the membership history of the Branch from its inception. The attempt was necessary for two reasons:

 No proper and adequate financial records were maintained during the Branch's earlier days.

b. Membership subscriptions received are divisible equally between the Branch and the National Executive, and both those bodies did in the first receive subscriptions — but the system for mutual reimbursement was unsatisfactory, and not complied with by the Branch.

3. Accordingly, Schedule 3 to both statements showed a balance owing to the Branch by the National Executive in the sum of \$156.00. I regret to advise that that figure was in error, because I had not made due allowance for the fact that no part of the subscriptions received by the Branch had been reimbursed to the National Executive. This fact was discovered by our Executive Director, Mr John Purcell, after much burning of the midnight oil. In August last we received what then appeared to be the amount owing to us, \$64.00. But that figure, too was slightly in error — and \$2.50 has been repaid (a member had been double counted, because of the way I had prepared the Schedules).

4. Schedule 3 to the present statements has therefore been prepared as a consolidated membership subscriptions transfer account to cover the whole period from the inception of the Branch till 30 June last. There seems no doubt that all difficulties have been resolved, and hence no reimbursements between the Branch and the National Executive were outstanding at that date. My successor as Branch Honory Treasurer should have no difficulties in this regard.

5. To summarize: the Statement of Assets and Liabilities as at 30 June 1977 showed assets of \$388.78. That figure was overstated by \$94.50, and should have been \$294.28. The Statement of Assets and Liabilities as at 30 June 1978 shows assets of \$375.16, an increase of \$80.88, or almost 28%, a not unreasonable figure.



Fellow Members,

The year following the election of the present Committee on 28th July, 1977 has been one of positive achievement and re-adjustment for the NSW Branch.

The Ninth National Conference

The outstanding accomplishment of the 1977/78 year has been the conducting of the Ninth National Conference of the Australian Crime Prevention Council on the theme "Society at Risk"

Held at International House, University of Sydney, Sydney, from 11th-17th August, 1977, it brought together international guests,

visitors and guest speakers from every State and Territory in Australia, nearly 200 delegates, and a program and organisation which has been highly praised. It evoked not only great media interest, but saw the cross fertilisation of ideas and the birth of new ideas in the multi-disciplined area of crime prevention, correction and after care.

The international guest speakers;

 Dr. Gerhard Muller, Chief, Crime Prevention and Criminal Justice Branch of the United Nations.

Mrs. Jean Floud, an English educationist, sociologist and economist from Cambridge University, U.K.

Mr. Wayne Jackson, Chief of the Division of Probation, Washington, USA Mr. William Clifford, Director of the Australian Institute of

Criminology. Mr. Alan Wilson, President of International Prisoners Aid

Society.

 all made impressive contributions to the Conference, whilst other overseas visitors like the New York Sociologist, Miss Freda Adler, and over 40 quest speakers plus the contributions from the floor at every Session, made this Conference a most participative, stimulating and challenging gathering.

Much credit for the Conference's success must go to the

Programme Sub-Committee, particularly to its Chairman, Mr. Rod Purvis and our National Vice President, Mr. Frank Hayes and to Mrs. P. Walker for the final Program. It would, however, be unjust to give credit to the Program Sub-Committee alone (which also included Judge W.P. Redapple, Mrs. M. Dewdney, Mrs. M. North, Mr. A. Restuccia), without recognising the outstanding efforts of all the enduring members of the Planning Committee who gave time freely, voluntarily and at personal inconvenience to the Conference from the initial meeting on 20th May, 1976.

With Mr. R. J. Batkin, as Chairman, Mr. K. Downs, Judge W. P. Redapple and Mrs. F. P. Walker, the Conference Treasurer, formed a very hard working Finance Sub-Committee which obtained a \$1000 donation from the State Government, donations exceeding \$5000 from major Companies and Banks, made no bad debts, and achieved a clear nett profit. Judge Redapple was our effective media organiser, and Mr. Chris Cunliffe-Jones, an excellent Conference Secretary. Inspector R. Holles, and Superintendent Grant Fryer excelled in the transport and accommodation arrangements. Mrs. M. Dewdney arranged typing of the Program and Report at crucial times. Your Branch Secretary was a useful Conference troubleshooter, while the Branch Chairman as Conference Chairman gave positive leadership throughout. Credit too, must go to the experienced Mrs. M. North, the Conference Co-ordinator, for the excellent arrangements and hard work over many months, and to Miss Jan Lawrie, for her help with essential typing and registration during the Conference itself. The practical assistance of the Dept. of the Attorney General and of Justice, the Reserve Bank, the Police Department, the Milperra College of Advanced Education, and the official Conference carrier, Ansett Airlines, is also acknowledged.

That the Conference was a success is widely recognised. It will go down as an example for future Conferences. Yet this result primarily, came from a handful of very diverse people on the Planning Committee who were prepared to make personal sacrifices to provide this Branch and this State with a creditable Conference. Their zeal, their wisdom, their initiative, their willingness to co-operate together was the key to their success. To them, this Branch on its own and on behalf of the President and members of the National Council of A.C.P.C. extends its unreserved gratitude.

Balance of the Year

I have dwelt upon the Conference for it was the high point of the year under review. All thereafter has been an anti-climax by comparison. The balance of the year has been either a timeconsuming but necessary winding up of the Conference affairs, e.g., arranging printing of the Conference Report, thanking official guests, considering refund applications, etc., or, an exploration - a search for the activities desired by members and potential members which will assist them in their contribution to reducing the incidence of

Our Board Membership totals 40. It must be increased. Fortunately, it already contains the major State organisations concerned in this field, both voluntary and public.

Conscious of the limitations of its membership, the Branch has

undertaken the following other activities. It has:-

- 1. Opened the monthly committee meetings to all Branch members and altered the meeting time to 5.15 p.m. This has increased the number present during significant Branch decisions. All committee members attended a majority of committee meetings.
- 2 Sought and received a Report on membership extension.
- Called a meeting on 22nd June, 1978 to consider the future of the Branch and its most appropriate role(s). The need for upto-date information of benefit to the workers in the field of

crime prevention was highlighted as well as recognising the

- Branch's important initiating and co-operating role.

 Introduced "conversational" discussions over dinner with informed speakers on specific themes. One such Dinner has been held, viz., on 17th March, 1978 with Dr. Leslie Button, an expert on the problems of adolescents and young people, particularly through community and group work. The discussion was valuable. The response was very encouraging. Thanks are extended to Mr. F. Hayes, Mrs. P. Walker, and Mr. A. Restuccia for organising this function. The next dinner is being arranged on "Community work orders".
- Proposed a Seminar on Research which received support, but had to be cancelled. Hopefully, it may be held later. At present a Seminar on Crime Prevention is being arranged for later this year.
- 6. Sought to establish the principle of discussing with its State Representative matters for presentation to the National Executive.
- Considered, then advised the Federal President of its support for the continuance of an A.C.P.C. National Secretariat despite financial difficulties.
- 8. Moved at the National Council Meeting held on 18th August, 1977, through its Branch members, Mr. A. Restuccia, and Mrs. M. North, the need for a quarterly National Newsletter or Bulletin. The motion was adopted unanimously. The National
- Council has since published two News Bulletins.

 9. Contacted the NSW Committee organising the 1980 U.N. Conference on the Prevention of Crime and Treatment of Offenders offering assistance. This Congress is to be held in Sydney from 25th August to 5th September, 1980. The extent of our Branch involvement, whilst acknowledged and expected, has not yet been resolved. Further discussions are anticipated shortly with the State Committee, and members will be advised.

Looking Ahead to 1979.

Apart from Information Meetings (Seminars, Dinners,) the two major concerns for the Branch will be

- 1. to establish its role in the planning and preparations for the 1980 U.N. Congress, and
- 2. to widen its membership and increase the opportunities for greater co-operation between members and by individuals so that they may perform their specific roles more effectively. The Branch contains members who have much to contribute to the

fight against crime in our community. In the development of potential and the improvement of services, the Branch can act for its diverse members as it has done so effectively before, either alone or through the National Council.

Following the Annual General Meeting the Branch Committee has held regular monthly meetings, and arranged the following: 1. Seminar — Administration of Criminal Justice in South Australia. Held in November, 1977, the seminar was arranged in conjunction with the Department of Continuing Education at Adelaide University. Speakers were the Hon. D. Simmons, Chief Secretary; the Hon. J. Burdett, shadow Attorney General and Mr. C. K. Stuart, Government and Opposition speakers outlined their policies and Mr. Stuart gave the most entertaining speech on shortcomings in criminal justice, especially in the juvenile field. Attendance at the seminar was good.

- Seminar Relationship between Schools, Education and Crime. This seminar, organized by the Committee, was held in March, 1978. Guest speakers represented Police, Education Department, Parents Association and Teachers Institute. Good participation and subsequent publicity of the topic made the seminar a success.
- Seminar Probation and Parole.

To be held at the University on 1st August, this is arranged with Continuing Education, utilising the visiting Chief Probation Officers, in Adelaide for their Annual Conference. At the time of writing, the seminar was pending.

Other matters pursued by the Committee has been linking with a Crime Prevention Programme run by the Kiwanis, a project still being explored; provision of Crime Prevention material from the Police Department to the Chamber of Commerce for publication in their journal, and preparation of material for further school based seminars on delinquency, etc.

The South Australian Branch of the Australian Crime Prevention Council is not growing at the present, and this is due to the joint problem of committee members who are already busy in the Crime Prevention field with limited time and energy to run programmes to attract interested people. 
