New Member of the Court to make his solemn declaration *"

The following information is communicated to the press by the Registry of the International Court of Justice:

On Monday 17 February 1986, at 12.30 p.m., the Court will hold a public sitting in the Peace Palace, The Hague, for the purpose of enabling Judge Nikolai K. Tarassov (USSR), who was on 9 December 1985 elected a Member of the Court by the United Nations General Assembly and Security Council, to make the solemn declaration required by Article 20 of the Statute of the Court.

Judge Tarassov has been elected to fill the vacancy left by the resignation in August 1985 of Judge Platon D. Morozov (USSR).

Counsellor, Embassy of the USSR in Iran (1956-1961).

Head of section, Deputy Head of Department, and Head of Department in the Ministry of Foreign Affairs of the USSR (1961-1968).

Deputy Permanent Representative of the USSR to the United Nations, New York (1968-1972).

Ambassador of the USSR to Mexico (1972-1976).

From 1976 to his election to the Court, Principal Counsellor, Department of Foreign Policy Planning, Ministry of Foreign Affairs of the USSR.
