"What on earth have they cleared there?" I asked the taxi driver as he sped me to my dinner date at a great Japanese restaurant in South Brisbane. South Brisbane at night is a dark place at the best of times but it is unusual to see a whole block razed to the ground allowing full city views. "They're finally doing the new Convention Centre" he replied; taxi drivers, of course, being the font of all knowledge.

His use of the word 'finally' struck me. It obviously wasn't just me who had given up on there ever being a purpose built Convention Centre in Brisbane. When the Queensland members of ALLG asked Canberra in 1989 to take on the 1991 conference and Brisbane to do the 1993, it never occurred to us that the Conference Centre, planned as part of the Expo '88 site redevelopment, would still not have had a sod turned by June 1993. The impact of this ever so slow property development has had ramifications on the whole of Brisbane's hotel and convention planning. It has been a key influence on the '93 Specials, Health and Law Librarians' Conference planning and structure

"If you have always done it that way, think again." That's the headline of an article in the Business Review Weekly for 7 May 1993 that talks about paradigm shifts, TQM, sustainable productivity improvements and workflow engineering as the significant determinants of business success in the 21st century. CREATING OUR FUIURE registration at 31 March!


