**Q:** I am looking for (1986) 2 IPJ but it doesn't correspond with my library's IPJs.

**A:** IPJ stands for *Intellectual Property Journal*. However there were two journals with that name. One published by Carswell started in 1985 and one published by Law Book Company in 1990. To confuse things the Canadian journal published Australian contributions. Fortunately with Vol 3 (1992) the LBC journal changed its name to *Australian Intellectual Property Journal* hence AIPJ.

**Q:** What is the difference between the *Macquarie Dictionary* 2nd edition and the 2nd revised edition?

**A:** In between the 1st and 2nd editions there were at least two "revised" editions. Having visited a bookseller I noticed that "couch potato" was defined in the 2nd edition, but not in the 2nd revised edition. So beware of the dud spud!

**Q:** Please get me the federal money laundering legislation.

**A:** With the assistance of DISKROM Commonwealth Statutes May 1993 release, keyed in money w/10 laundering and yielded: *Mutual Assistance in Criminal Matters Act 1987 (Cth) and Proceeds of Crimes Act 1987 (Cth)*

**Q:** I'm after *Downsview Nominees Ltd v. First City Corp Ltd* [1993] *British Company Cases* 46. Our library has *Butterworths Company Law Cases* but it wasn't reported there as at June 1993.

**A:** Fortunately CCH does reproduce some of its overseas companies cases in *Australian Company Law Cases* and in this instance the case was reproduced at (1993) 11 ACLC 3,

101. Secondly, on checking the *Law Reports* 1993 cumulative index 23 April 1993, which doesn't index BCC or BCLC, the case was noted as reported in [1993] 2 WLR 86.

**Q:** I have found the recent High Court decision regarding Cambodian boat people : *Chu Kheng Lim v. Minister for Immigration, Local Government and Ethnic Affairs*. The *Australian Law Journal Reports* reference (1993) 67 ALJR 125 and the *Australian Law Reports* reference (1992) 110 ALR 97 have the case indexed under Chu whereas the *Australian Legal Monthly Digest* has the case under Lim. Which is correct?

**A:** Lim, as Lim is the surname.

**Q:** What has happened to English solicitors in *Kime's International Law Directory*? In the 1991/92 edition they were listed under Great Britain.

**A:** In the 1992/93 edition, English solicitors are listed under United Kingdom.

**Q:** I understand Bond Corporation changed its name recently. What is its new name, as I want to find out about its current litigation matters?

**A:** Southern Equities Corporation, and there already are a few cases decided under this name.
