Several people commented that the real problem is not with the currency of the Citator itself but with the long delay in reporting many cases, particularly NSW Court of Appeal. If the promptness of reporting were improved the indexing would also improve.
- 2. Excess updating we are going to monitor looseleaf services to see if pages are replaced with no amendments being made. We will let you know the results

I applaud Law Book Company for updating the Australian Case Citator more frequently, but I deplore the fact that this is done at extra cost to the consumer. It seems to create a precedent. The subscriber complains about inefficiency or untimeliness of updating, then we pay for its upgrading. By rights, it should have been timely in the first place.

I attach a list of the various UK titles available through Australian agents and their comparative prices if purchased overseas and delivered to Australia

Many Australian law libraries have overseas associations who can supply this material much more cost effectively than using Australian agents

I am very concerned that publishers with exclusive Australian agents seem to be taking advantage of that exclusive position by charging excessively high rates

I am also concerned at the approach taken by Law Book Company to renewals. The form letter 'Renewal of your annual subscriptions' states " we have given you the opportunity to defer payment of this invoice for an additional 60 days. This means that payment is not due until 28 February 1994." The letter, however, later states, "If we have not heard from you by 17 December 1993 we will automatically renew your subscription."

The 1993 edition of this arrived in the mail yesterday The publisher's note begins:

"This work is a consolidation of the bound volume (1558-1972) and the Supplement (1973-1991/92) and will supersede both these works. It also includes the latest supplement material received by the Editor up to early 1993."

The volume came with a slip of paper saying simply: "Notice to subscribers: Please retain the Australian and New Zealand Citator to UK Reports 1558-1972" No reasons were given However, the last paragraph of the Publisher's Note reads:

"The Index appearing at p 1243 of this work covers the cases from 1973-1992/93. Readers should refer to the previous consolidation 1558-1972 for the Index covering the period prior to 1973"

So much for being a consolidation and "superseding"! I gather I was not the only one to complain

AGPS have invited selected customers of AGPS to air their views on the service-products provided AGPS were very disappointed to note that the feedback was rather negative. A customer survey to follow this up will be conducted in May 1994

AGPS are now undergoing a number of changes to try to address some of the

customer complaints they have been receiving. Some of these include:


- annual invoicing
- bookshops operating on a WAN to allow better stock management
- each customer to be given the name of a contact who will handle all their account queries
- electronic network access to the Attorney-General's Department in Canberra - the aim of this is to print legislation/bills on demand at the bookshops
- improving the dispatch of materials
- getting the bookshops to return their focus to government information
- bookshops will provide more information electronically or in machine readable format.

The printing of Commonwealth legislation is dictated by the Attorney-General's Department and as such is out of the power of AGPS AGPS is aware that bound volumes of statutes, in particular, are produced very slowly and are trying to address this issue with the Department.

AGPS are trying to rationalise their dispatch process so that subscribers to periodical gazettes and other small items do not have two items despatched, both with a minimum \$5 invoice, on the same day in separate envelopes incurring the \$5 charge twice

The delay of dispatch of bills on subscription was mentioned and Rob Fontanot will look into this as they should be despatched as soon as they are available
