New Commonwealth Industrial Relations Legislation

The new Commonwealth industrial relations legislation, the Industrial Relations Reform Act 1993 (no.98 of 1993) came into force on 30 March 1994 The Act received the Royal Assent on 22 December 1993. Part One of the Act (preliminary only) came into force on the same day, the remainder on 30 March 1994 The Act seeks to achieve major labour market reforms (see the second reading speech House of Representatives, Debates, 28 October 1993) by amending the Industrial Relations Act 1988 and incorporates in Schedule One, the following International Organisation conventions recommendations:

- Minimum Wage Fixing Convention, 1970:
- Equal Remuneration Convention, 1951;
- Equal Remuneration Recommendation, 1951:
- International Covenant on Economic, Social and Cultural Rights 1966 (preamble and parts II and III);
- Discrimination (employment and Occupation) Recommendation, 1958;
- Termination of Employment Convention, 1982;
- Iermination of Employment Recommendation, 1982;
- Workers with Family Responsibilities Convention, 1981;
- Workers with Family Responsibilities Recommendation, 1981.

Malaysian Legislation

For one reason or another, possibly because of its frequent coverage in the media, researchers are often pursuing Malaysian legislation Until recently this has been very difficult to find because of its publication in the official Malaysian Government Gazette and poor indexing There is no official reprint programme This situation has been remedied by the publication of Golden's Federal Statutes (Laws of Malaysia) by International Law Book Services (14, First Floor, Lorong Bunus Enam, Off Jalan Masjid India, 50100 Kuala Lumpur, Malaysia, Fax: 03-3938035) Price, approximately \$A1500 establishment and \$A300 per annum

This commercial compilation of the federal laws of Malaysia currently consists of twenty five looseleaf volumes and is still growing Reprinted Acts are included with details of all amending legislation and regular updates are received which include both replacement pages and annotation instructions.
