The Pagination Frustration: Electronic Judgments and Page References

Locating pertinent judicial opinions on point is today made far easier with the advent of court decisions in electronic format We no longer must rely solely on the judgment and discretion of indexers who compile subject indexes and Words and Phrases tables to reported decisions Instead, if a court's decisions are available electronically, we can search for specific phrases or terms in proximate relationship to each other Yet herein lies a problem In pagination terms, *where* in the judgment does the desired phrase actually lie?

In illustration, decisions of the High Court electronically accessible on SCALE and Diskrom's Federal Cases CD-ROM do not provide page numbers to the official report series of the court, nor indeed, of any other published version. To contradict, in part, my previous statement. I have seen the occasional round-bracketed page reference on the Federal Cases CD-ROM, but the infrequency of this citing makes it almost a hindrance rather than a help, given that I can never be consistent or entirely accurate when I explain the use of the ROM to new users As a further aside, I have been disappointed with the unreliability of the Diskrom Federal Cases disk when electing to search in a particular domain If I select Federal Court cases only and proceed with the search, my results almost inevitably end up with a few High Court cases thrown in for good measure

To return to pagination. If a passage of a judgment is located electronically and you need to provide the actual page reference for your client (a desirable service, particularly if you happen to find a quote in the *Banking Case*), you must resort to grabbing a copy of the published report and:

- a) rely on memory or serendipity to find the quote;
- b) find a cited case mentioned in or around the needed quote then look up the Table of Cases Cited in the published report for the page reference; or
- c) read the entire published report until you find the quote.

All of the above are tedious and clumsy and serve to almost negate the speed of the electronic search

In the United States, the American Bar Association is taking steps to develop a citation convention based more on the "content rather than the ultimately arbitrary geography of paper By functioning according to content rather than paper dimensions, a citation convention would better accommodate electronic media." [Taken from an Internet copy of the ABA's Draft Resolution of the House of Delegates, sent to all subscribers on the Law-List listserv] In plain English, the ABA is advocating case citations which are independent of the volume and page references of a particular publisher's report series We are already familiar with statutory citations which refer to sections of an act and not to the page reference and volume number of the published version of the act. In addition, legislation cites are content specific in that the section cited is directly related to the content of the act and independent of paper limitations as to what page the section starts and finishes on

The push by the ABA for the development of a content-related, publisher-independent citation convention for cases, is driven principally by the copyright problems which arise when publishers claim ownership in their pagination See, West Publishing Co v Mead Data Central 616 F Supp 1219; aff'd 799 F 2d 1219; cert denied 479 US 1070 (1987). We have seen similar problems arise in Australian electronic legal publishing

The Americans do not yet have an answer to what form the case citation will take, perhaps it is to be controlled by the ruling court Yet they are on an interesting track and one which, if the "content-related" aspect of the citation were realised, could serve to alter the shape of a judgment I recall, as a student, how welcome a judgment was when the judge provided headings for particular sections of his judgment, it made locating the pertinent point far simpler.
