- Q. When did John Marsden become a councillor of the Law Society of New South Wales? It isn't mentioned in his entry for Who's Who in Australia.
- A. 1984 He is mentioned as a Councillor at the contents page in the (1984) 22

 Law Society Journal 763 Surprisingly during 1985 the Councillors weren't mentioned on the contents page of the Law Society Journal In 1986 the latter was restored.
- Q. Is there a map available of New South Wales local government areas?
- A. There is one conveniently reproduced in New South Wales Government Gazette No 67, 12 May 1994 Special Supplement at page 2157 then followed by Sydney, Newcastle & Wollongong local government areas then followed by one for Sydney

- Q. What is FCPA? Its an American legal abbreviation and isn't in Price, MM Bieber's *Dictionary of Legal Abbreviations*, 4th ed, Buffalo: Hein, 1993.
- A. Keyed in FCPA in Wilsondisc Index to Legal Periodicals and came up with Foreign Corrupt Practices Act 1977.
- Q. I'm after the Pioneer case which went to the Privy Council in the late seventies.

 There's nothing in the Law Reports Index 1971-80.
- After finding nothing, the enquirer informed me the correct party's name was South Coast Basalt Pty Ltd, a subsidiary of Pioneer, and considered the Sale of Goods Act (NSW) s.19 Turning Butterworths NSWStatutes Annotations 1993 consolidation there was only a reference to the unreported NSW Supreme Court judgment of 22 April 1977 Law Book Company's NSW Statutes Annotations and References 1824-1988 yielded South Coast Basalt Pty Ltd v RW Miller & Co Pty Ltd [1981] 1 NSWLR 356 which was the Privy Council reference

- A. It is in the 1989 indexes to *International*Legal Materials under Jurisdiction then
 Enforcement of judgments.
- Q. On Austrom's CD-ROM for AGIS and APAIS which is the preferred term for the United Kingdom: England, United Kingdom or Great Britain?
- A AGIS United Kingdom APAIS Great Britain
- Q. I'm after [1992] BCC 58 and I don't have the name of the case, but it does consider Linter Textiles Corp Itd, Re [1991] 2 VR 561. We have the BCLCs and the Cumulative index to BCLCs 1983-92 but there is no table for cases judicially considered. I also checked the Australian Company Law Cases as they put in selected BCC's.
- A Put in the Lawpac CD-ROM for unreported judgments Disc 2 1990-94 and keyed in "BCC near 58" and found two references, which told me the name of the case Re British and Commonwealth Holdings plc (No 3) which I found in [1992] BCLC 322.
