A Comprehensive National Legal Directory: the Detailing of Counsel, Corporations, Courts and Campus

There are various directories available which contain different pieces of legal information Listings of solicitors, barristers, legal firms and legal institutions are available in the Australian Legal Directory Law societies within some states publish a legal directory. The Law Institute of Victoria publishes The Legal Directory which includes, among other items, the names of Victorian law firms and barristers. The names of all the major courts and tribunals, details of their function, administration, registries and names of judges, commissioners and members, where relevant, are noted in the various Commonwealth and State government directories. A major generalist directory, The World of Learning, contains entries for law schools which are placed under the relevant university. The name of the dean together with a listing of full professors for each law school are also entered

All the above directories are readily available However, apart from and due to the inherent problems associated with the content, placement and currency of this information, I would like to see made available a comprehensive national directory which incorporates all of the above elements, and perhaps more

With regard to content, while the elements are stated, certain details concerning these elements are sometimes either scattered among the various directories, or simply omitted For instance, the listing of barristers in the Victoria Law Institute's *The Legal Directory*, includes the floor and room number in chambers for each barrister. This

information is not included in the Australian Legal Directory The Legal Directory includes the name and telephone number of the clerk for each barrister. It further gives the barrister's room telephone number. The Australian Legal Directory, while substituting a code for the name of the clerk, does not give a key for this code. It does however list a telephone number against the name of each barrister. I was able to identify the names of the clerks in Victoria by the trial and error method of cross checking this telephone number against those entered in The Legal Directory

Barristers' rooms and the names of their clerks are important details. As stated in *The Legal Directory* "barristers move chambers frequently, it is not possible to accurately specify locations Solicitors should check with the barrister's clerk to discover present location". Clerks are not to be regarded as support or ancillary staff. Apart from displaying the characteristics of a business organisation they are the 'front door' through which solicitors obtain the services of barristers.

J Myron Jacobstein and Roy Mersky in Fundamentals of Legal Research have described the purpose of law directories as being "useful in locating information about a particular lawyer and [being] used by many lawyers when they have to refer a case to a lawyer in another city". A Special Committee of the American Bar Association, in 1935, developed Rules and Standards as to Law Lists Since that time many of the lists and directories published are certified by the American Bar Association

In particular, the Martindale-Hubbell Law Directory contains a listing of all lawyers admitted to the bar, and information is given for date of birth, date of admission to the bar, college and law school attended, American Bar Association membership and speciality. An International Lawyers' Section is included in volume VII The major Australian law firms together with the

names of the partners and senior associates are listed Ratings information, as stated by the *Directory*, is based upon 'confidential recommendations from lawyers and judges in the place or area where the lawyer practises, and at times from such sources elsewhere' Jacobstein and Mersky expand on this statement to say that the ratings estimate legal ability, recommendations and promptness in paying bills - a most important factor in these penurious times It is evident that to have a national listing of names together with details, cited in the one directory, as they appear in Martindale-Hubbell, would be useful, especially from a practitioner's point of view

A second factor regarding not only content, but placement, concerns the area of the listing of courts A listing of courts and tribunals, each one differing in content, may be found in the Commonwealth Government Directory, each of the state government directories, the Australian Legal Directory and the relevant Law Institute Legal Directory. In the case of the Commonwealth Government Directory, the major courts are listed under the heading 'Courts and Tribunals', however tribunals such as the Social Security Appeals Iribunal and the Student Assistance Review Tribunal are placed under the relevant department. Information concerning court fees or filing fees and court sittings are located in the Law Institute of Victoria Legal Directory

The content of the third element, that of law schools and their staff, is limited to that of the dean and the names of full professors only. This exempts a large body of academically sound and active people. Should such a national listing be put together it ought to reflect the specialty in subject area of the incumbent.

All of the above-mentioned elements appear in some form or other but are dispersed in various directories I would like to see a move on the part of the publishing world to produce either in looseleaf format, or CD-ROM, a comprehensive national legal directory incorporating all of the mentioned elements, together with a complete set of details One further element should definitely be incorporated: that of a listing of legal librarians
