Just Re: Awards

"Federal awards govern the basic terms and conditions of employment for several million Australians Many workers and their unions have also entered into workplace or enterprise agreements Such agreements can add to, supplement or even replace the terms of their awards, but how many of us know what is in our awards - or how to find out? And what about agreements?" This statement is taken from Reading Your Award and Agreement: A Guide produced by the Australian Trade Union Training Authority (TUTA)

Knowing what is in our awards and how to find out should be regarded as a normal if not necessary adjunct to our working lives. In order to procure this knowledge we must first be able to obtain the text of the appropriate award together with any attendant variations. The TUTA booklet provides a brief yet excellent guide to the content and understanding of awards and agreements. It also mentions where to obtain awards and gives a list of addresses in Appendix 1.

Obtaining awards would therefore appear to be a fairly straightforward matter. You simply contact the appropriate Australian Industrial Registry Office in your state and ask for the award to be sent to your address. But which award do you ask for? What the booklet fails to describe are the specific elements needed to be known before an award, together with any relevant variations, can be located. This is not the fault of the booklet as it is intended primarily as a "practical guide for job representatives and union organisers" i e people already familiar with, or whose task it is to become familiar with, the location, content and purpose of awards.

Key Elements for Finding Awards

Few people employed outside the industrial relations arena would know the specific element/s necessary to locate an award. Included are those librarians whose libraries are not heavily involved in this area and who therefore are not conversant with the requirements for locating such material

The *specific element/s* are: the correct title of the award and/or the unique identification or code number

Apart from having a copy in hand, how are these elements located? It is at this very basic level - the obtaining of these element/s - that what would ordinarily appear to be an elementary task becomes rather more complex.

A fairly typical request in a broad-based research or firm library may be illustrated with the following example: a request is made for a copy of an award concerning clothing entitlement for flight attendants

Sources of Awards

I first need to know either the title or identification number of the award governing the working conditions for flight attendants in order that I may then locate the full text of the award. What are the relevant sources which will give me this information?

I commenced a search in three major looseleaf services whose subject matter covered the areas of industrial law, employment law and labour law I found however that while the contents index of these services mentioned the term awards the paragraphs only contained commentary on particular legal aspects of the term Awards were not cited by name, neither was there a listing for them in any of the contents pages

The second source which I approached was the Australian Industrial Relations Commission (AIRC) Awards List Alphabetical 21 March 1994. On leafing through this publication I became aware for the first time that one of the major problems associated with locating titles of awards was the fact that the titles do not reflect the specific nature of the work performed; rather they are placed under either generic headings covering a multitude of specific employment areas, or the name of a particular company, i.e. the Metals Industry or ACI Insulation Therefore, apart from the fact that the Awards List is nearly one year out of date I was unable to locate the term "flight attendants" in the listing Further, unless the title of the award is known, no useful purpose is served by consulting the Awards List Numerical Listing

The final avenue left to explore was FAIEXT, an online database containing among other data the full text of federal awards, certified agreements, enterprise flexibility agreements and variations. Why did I leave this source till last? First, I did not have ready access to this database. Secondly, I have always felt that fee paying databases should only be resorted to after readily available and relevant printed sources have been consulted, or when the client is fee paying and/or the information is urgently required. Thirdly, I had hear d that searching FAIEXT was both cumbersome and user unfriendly.

I rang the 008 number for the help line and was greeted by an extremely user friendly FATEXT member of staff, Philip Gausden, who did his utmost to convince me that the database was of considerable importance and that thorough training in the construction of viable search strategies was vital before commencing a search, the latter in which I have always firmly believed.

He explained to me the correct form in which to place my first search strategy A number of hits were retrieved as flight attendants are covered by both domestic and overseas awards. Rather than running up costs by sub-questioning each title for the word clothing or uniform I chose to note the identification/code numbers of the awards retrieved, log off, and go to the print copies on the shelf I felt relieved that I had not been asked for a similar request concerning clerical workers as the list retrieved after truncating clerk would have exceeded well over 100 hits

A further problem arises when attempting to locate the latest variation to an award. Many printed awards have not been consolidated, some since the 1970s Such awards may have up to 160 variations attached. This problem can be alleviated through using FATEXI as the database contains a "consolidated looseleaf of all current federal awards"

The end result of this search process pointed to the fact that, apart from seeking advice from various phone contacts, FATEXT is the only viable first point of entry for accessing the correct title and/or identification/code number of an award However this method can prove to be cumbersome, costly and time-consuming I recommend the production of a comprehensive subject index to awards If this presents as an untenable task then I suggest that FAIEXI be produced in CD-ROM format and updated monthly Depending on the search software chosen, it would have to be a more marketable and productive source of accessing first the title, and then the full text of awards, than the means currently utilised

The bibliographic detail is excellent. Not only are Commonwealth and NSW acts listed, but also Australian and UK standards and detailed bibliographies of all reports published by the Australian and New Zealand Environment and Conservation Council, National Health and Medical Research Council, National Occupational Health and Safety Commission, Workcover Authority of NSW, International Programme on Chemical Safety, World Health Organisation and the National Institute of Occupational Safety and Health (US)

ACT supplement to The law handbook (NSW) Geoffrey Howard 5th ed. Canberra: Law Faculty, Australian National University, 1994. Iv (various pagings) ISBN 0731520793.

As the Australian Capital Territory has few guides to its legal system, this supplement to *The law handbook*, published by the Redfern Legal Centre, is probably the nearest the territory has to a legal encyclopaedia

Appendix 1 on pages 739-746 contains a list of *Treaties relating to the environment and conservation*, adapted from information supplied by the Dept of Foreign Affairs and Irade, while Appendix 2 on pages 747-797 has a table of *Environment legislation in Australia*, arranged by jurisdiction and subject, from information supplied by law firm Freehill Hollingdale & Page
