United Kingdom and European Law CD-ROMs

London based electronic publisher, Context, who specialises in European and United Kingdom official and law sources, now provide a series of CD-ROM law resources under the collective title Justis. The Justis CD-ROMs include Celex, the official legal database of the European Communities containing over forty-one years of treaties, regulations, directives and case law, and Official Journal (C Series) which covers proposed legislation, notices of European Court of Justice cases and activities of the European parliament

Other useful Justis CD-ROMs include Parliament Service, a bibliography and index of proceedings and publications of United Kingdom parliaments from 1979, Weekly Law, containing the full text of the Weekly Law Reports from 1981 onwards, and Industrial Cases, which is very new and contains reports of cases and hearings from the Employment Appeal Tribunal, the Courts of Appeal, House of Lords, High Court and Industrial Iribunals Industrial cases also includes reports from the Restrictive Practices Cases series.

Another potentially very useful Justis CD-ROM Eastern Europe, containing the full text of current commercial law of Bulgaria, Hungary, Poland, and the Czech and Slovak Republics translated into English It is published jointly with Deloitte I ouche Tohmatsu

Context offers an online service to update some of their CD-ROM products, e.g. Celex and Weekly Law, the latter being updated weekly online Current online databases include The Times Law

Reports, The Independent Law Reports, Northern Ireland Bulletin of Law, and Criminal Appeal Office Index of Judgements.

An enterprising new provider based in Texas is publishing CD-ROM and diskette databases of Chinese law in both English and Chinese Their name is AsiaInfo Services Inc. and they claim to have the approval of Chinese Government ministries and departments for their data

Child Abuse and Neglect CD-ROM

The Elizabeth Evatt Library (Sydney) of the Family Court Library Network has just received a new CD-ROM - Child Abuse and Neglect database from 1965 to the present

It is produced by the National Clearinghouse on Child Abuse and Neglect Information (a US government agency), and replaces the Child Abuse and Neglect online database, formerly available on DIALOG. I am grateful to John Myrtle of the Australian Institute of Criminology for alerting me to the fact that the online version was to be replaced by CD-ROM.

The disk contains the world's largest collection of citations and abstracts on the maltreatment of children There are databases containing references to the professional literature, public education materials, audio-visual materials, (US) state statutes, and information on national

prevention programmes and national and international organisations. It is targeted towards professionals and practitioners, including lawyers, researchers, policy-makers and administrators in the field of child protection.

The Documents database contains 18,000 citations and abstracts of professional literature, (including court cases from 1965 to 1986), in the areas of physical, emotional, psychological and sexual abuse and child neglect. The Organizations database profiles organisations working in the area of child abuse prevention and treatment. Regularly up-dated records contain full contact information, and brief descriptions of organisational focus, as well as services and products provided The database of Public Awareness materials for children and adults contains references to books, brochures, comic books, pamphlets, colouring books, workbooks and fact sheets The Audio-visual database contains descriptions of audio-visuals intended for a wide range of audiences, from children to law enforcement professionals Various media include audio and video-tapes, games, films, multi-media packages and anatomically correct dolls. The State Statutes database contains summaries of the legislative provisions related to child maltreatment in the fifty US states and territories, covering the state and federal aspects of reporting child abuse cases, procedure, admissibility of evidence, child testimony and more. The Program Directories database covers US local, state federal and international treatment programmes, family and youth services, shelter services, and mental health programmes.

The CD-ROM is available free to libraries and institutions who can prove a legitimate interest in its contents. It is also available by subscription To order, write on your organisation's letterhead to:
