The first meeting for 1995 was a social occasion hosted by Monash University Law Library on Friday 17 February About 40 members bravely ventured out of the city limits to the wilds of Clayton to sample some excellent catering and to inspect the extensive Law Library collection The Law Library has recently added a floor (four floors now) which precipitated a major rearrangement of the collection For many members this was their first opportunity to see the Monash collection Highlights on view included an extensive Pacific Islands collection, complete set of all Australian territories' legislation, a superb collection of US legislation and case law, and a growing variety of Asian material

The March meeting was devoted to an overview of the Online On Disc Conference held in Sydney in January Jill Bright (Australian Society of Certified Practising Accountants) spoke on the multimedia presentations given by two keynote speakers from the US Melissa Dunley (Dunhill Madden Butler) discussed Nancy Honig's (US) session on copyright, and Lianne Forster Knight (Mallesons Stephen Jaques) took us surfing through the Internet room at the Conference, discussed the fact that most papers mentioned the Internet in some way, and touched on security issues Adriaan Bendeler (Vic DPP) concluded with a roundup of social events and a product teview

Betty Moys was the star of our April meeting, and was as always an interesting and entertaining guest speaker. Betty has shifted her affections from classification and legal librarianship to the world of legal indexing and has now indexed a number of books including the current edition of Chitty on Contracts. The frightening part of this process is that she actually has to do something that I don't think anyone else beside the author has ever done—read the book from cover to cover!! Betty also briefly mentioned the various tools that can assist when compiling an index,

including the British and International Standards for indexing Betty is seen as a radical pioneer (in the legal field at least) of 'upside down' indexes in which narrow topics are listed first, and all entries are well cross referenced. Traditional legal indexes are arranged the other way - from broad subject headings to narrow - which as most librarians are aware makes them very difficult to use. Check out the latest edition of Chitty for Betty's name - she asserted her "moral right" of authorship under British intellectual property law to have her name added as author of the index

The difficult issue of copyright for libraries was the subject of our May meeting. Our panel of speakers included **Andrew Christie** of the Copyright Law Review Committee and Melbourne University; **Karen Skafti**, a solicitor from BHP who has had recent experience negotiating BHP's contract with CAL; and **Jamie Wodetski**, ACLIS's resident copyright expert. This was very useful to members as it highlighted the complexities of the *Copyright Act* and the difficulties inherent in compliance
