For our August meeting Gary Hardy demonstrated VICNET to a very large gathering of law librarians at Mallesons Stephen Jaques VICNET is a joint project between the State Library of Victoria and RMIT to provide access to the Internet for all Victorians (as Gary put it, to the 'brown cardigan' people) and to place Victorian information on the Internet VICNET allows community groups to cheaply publish information about their organisation and current events Gary encouraged us to form a home page for the ALLG and then to create an electronic version of our newsletter.

Gary alluded to developments in Victorian legal information becoming accessible on the Internet Hansard of the State Government is currently on trial, and full text of Victorian public law notices are available

He pointed us to the Australasian Legal Information Institute. This body was established by the University of New South Wales and the University of Technology, Sydney. It provides valuable links to legal resources on the net. From here one can go to full text materials, indexes to Australian legal resources; links to international indexes of legal resources and gateways to other legal databases. Full text materials newly added are High Court decisions since 1950, and some NSW Law Reform Commission reports
