University of the South Pacific Law Library

In 1994 the University of the South Pacific took its first intake of 78 LL B students on its Laucala campus in Suva, Fiji Prior to this the University had been running a Law Certificate course and Diploma in Legal Studies from the Pacific Law Unit on the University campus in Port Vila, Vanuatu The Law programme will be based at the Laucala campus of the University of Suva, Fiji, for 1995 as well From 1996 the Law Department will be based at the University campus in Port Vila. New buildings, including a library, are currently being built

At present the Department of Law has five members of staff including myself I was appointed in June 1994 The Foundation Professor, Mark Findlay, will arrive in February, 1995. His previous position was Director of the Institute of Criminology at the University of Sydney The other teaching staff are Professor Don Paterson, Mere Pulea, and Alan Marsh.

I have spent the last six months travelling and building the collection to support the teaching programme as it has been developed to date. This has been a slow road as until December I had no assistance from existing general library staff or law library staff. As of December I have had a law library assistant who will concentrate on processing the material for inclusion in the collection.

Obviously obtaining material for major common law countries such as Australia, New Zealand, the United Kingdom, Canada, and America has not been much of a problem except that the budget for 1994 was only \$F150,000 for current material and collection development! Fortunately I have received generous donations of material from colleagues in Australia, New Zealand and America, most notably, Victor Lipski from

Victoria University of Wellington, Margaret McAleese from Sydney University, Julia McMahon-O'Higgins from Auckland University, Jackie Patrick from the University of New South Wales, Nick Pengelley from Monash University, Lynn Pollack from the Law Courts Library, Sydney, Helen Wallace from the University of Western Australia and Lorraine Weinman from Commonwealth Attorney-General's Department The Asia Foundation, a non-profit organisation with an office in Suva, has also been highly supportive with book donations and They sponsored my assistance with travel attendance at the AALL meeting in Seattle and visits to major university law libraries down the West Coast of America and in Hawaii.

1995 promises to be another busy and varied year Shelving will arrive in Suva in March and I should have a functioning law library in place by April/May - but not for long! It is envisaged that the collection will be packed and shipped across to Vila to be merged with the collection already there (mainly Pacific legislation and law reports) in November

I will also be visiting the major island states to supplement the collection of Pacific law developed by Professor Paterson in Vila. Gaps need to be filled and unreported judgments, etc. collected and collated. The book budget for 1995 stands at \$F250,000 for recurrent material and collection development. As you are all aware, in Australian and New Zealand terms this is not substantial for an academic law library, so I do ask that if anyone has material they would like to donate or sell please contact me as follows:

Ten Prisoners, One Policeman and a Flat-topped Truck



In August last year, Rebecca Robinson and I spent two weeks in Western Samoa moving the Attorney-General's library It was moved from a very cramped 26 square metre room in an old German turn-of-the-century building, to the 4th floor of the new multi-storey Government Building, built on the waterfront as a gift from the Chinese government.

I had done a great deal of planning before the project started, including months of consultation and advice on the construction of the new shelves. These were built locally, and had most of the features I had suggested - like adjustable shelves.

Most librarians have moved a library at some stage of their working life I am sure no-one has moved a library without the "normal" aids of trolleys, boxes, and lifts


This move was very excitingly different. There were no trolleys; only about 50 cardboard boxes which we had to constantly re-label and re-use; and no lift, only a steep external stairway. However, we did have ten prisoners who carried the large and very heavy boxes down the stairs. I was rather concerned at being responsible for so many prisoners, so I was quite relieved to have a policeman detailed to supervise them. This only happened because one of the prisoners had escaped the day before the job started, so the Police Commissioner decided they should have proper supervision.

All went amazingly smoothly I stayed in the old library, packing with the help of the 'office prisoner', Fourteen (So called because he was the fourteenth child, he came in daily to clean the office and make the tea). Rebecca was positioned in the new building, unpacking with the help of one of the office staff, Maria Unfortunately there was no phone contact between us, no way for me to tell her 'leave more space for the All Englands, I've just found another shelf of them', so there was quite a bit of double handling.

Samoans are extremely strong people. Most of them could carry a box full of books single handed. They carried the boxes down the stairs and loaded them onto the flat-topped truck in the street below. There was no rope to tie anything down, and I was concerned that the boxes would bump off the truck, spilling law reports all over Beach Road, but the prisoners sat on them so the trips were accomplished safely.

We moved nearly 5,000 books in this fashion, and completed the job in five days

The new library looks very professional, and the Samoans are delighted with it. There was a colourful library-opening ceremony during the recent PILOM (Pacific Islands Law Officers' Meeting), attended by delegates from 15 Pacific countries and agencies.
