The CINCH Database

CINCH, the Australian Criminology Database is an index of Australian criminal justice subject matter. The database is produced by the Institute's JV Barry Library. It is available online through the National Library's OZLINE service and is also available as part of the AUSTROM CD-ROM. From 1995, 4,000 new records were added, all with abstracts, and the same number of records will be added in 1996. CINCH now has more than 32,600 records. The most recent updates of CINCH contained information on gun control, violence and coverage of the Port Arthur massacre. The records include newspaper coverage, editorials, articles and other information on the aftermath of April 28.
