#### Julia Butler retires

Julia Butler's retirement on 30 October 1996 will leave a gap in the ACI Division of the ALLG. Julia was officially farewelled at a meeting and lunch of the ACI Division on 26 September held at the Commonwealth DPP Office, and many people attended a lunch in her honour on 30 October that was held in the courtyard of the Kurrajong Hotel

Throughout her law library career Julia involved herself closely in ALLG activities. She was the State News coordinator for the Australian Law Librarian for several years and was a prominent member of the ALL Committee from 1993-1995. In her role as Advertising Manager, Julia worked hard to persuade booksellers and suppliers to advertise in the journal, with outstanding success. Her efforts were largely responsible for the Committee being able to hand over the journal to the present Adelaide Committee in a healthy state.

In addition, Julia was in charge of publicity for the 1991 Fourth Asian Pacific Special, Health and Law Librarians' Conference which was held in Canberra. It was Julia who found our talented graphic designer, Mariana Rollgejser, whose work for the Conference later led to the successful and enduring design for Australian Law Librarian. During the Conference Julia managed somehow to get a team of people to produce a newsletter every morning detailing the events of the day before and advertising the current day's programme.

In her career in the ACT, Julia was the first librarian at the Commonwealth Ombudsman Commission before her appointment to the position in charge of the ACT Supreme Court Library. After 9 years at the Court Julia moved in 1989 to be Deputy Librarian at the Lionel Murphy Library, Commonwealth Attorney-General's Department.

We all wish Julia great enjoyment in her new art studies at the ANU, and much happiness (especially in that enviable state of not having to get up to go to work!) We shall certainly miss her enthusiasm and cheerful presence as a 'working' member of the ALLG, ACT Division, however we hope she will still keep in touch with her former colleagues.

There has still been no meeting of the Working Group of the Tasmanian Legislation System Project The results of the market survey of legal practitioners and government agencies mentioned in the previous report have only just been received by the Project Team The question of electronic production seems increasing likely to be through the Internet, although a CD-ROM has not been completely ruled out A total of 24 of the most requested pieces of legislation have been identified and the data conversion process for these Acts has been completed, but there is no projected date for when they will be available either on a CD-ROM or on the Web
