Keynote Speakers

Sylvia Webb is an independent information management consultant from the UK. Sylvia has a formidable bibliography to her name including titles such as: Creating an Information Service, now in its 3rd edition, Preparing a Guide to Your Library and Information Service; World Wide Web. How to Design and Construct Home Pages, 'Know-How' and Information Provision in Legal Firms; Pursuing Quality in Special Libraries, Making a Charge for Library and Information Services, Promoting Excellence Personnel Management and Staff Development in Libraries, and more! Her keynote address is titled: "'Know-How' and Knowing How: Changing Context of Information Provision and the Role of the Professional."

Ch'ng Kim See is head of the Library at the Institute of Southeast Asian Studies, Singapore Kim See has extensive experience throughout Asia and will give us an invaluable insight into developments in our region. We hear often about closer ties Australian and New Zealand companies are making with business interests in

the Asia Pacific region and this is our chance to learn from the experiences of a colleague who is a regional leader, and to forge some ties of our own Kim See's keynote address is titled: "The II Thrust Toward the New Millennium: Asian Government Responses to Challenges of Information Technologies and Implications for Libraries in Japan, Malaysia, and Singapore."

Richard Danner is Associate Dean for Library and Computing Services and Research Professor of Law at the Duke Law School in Durham, North Carolina Richard's keynote address takes us to issues forming at the edge of the technological revolution. Who better to take us through some of the issues than one of the preeminent legal librarians in the US? Richard's experience in a number of offices in the American Association of Law Libraries (including President from 1989-1990) as well as in other law associations, and the interests reflected in his many publications guarantee us some new insights. Richard's keynote address is titled: "Defining a Profession."

Elizabeth Bole Eddison is Chairperson and Vice President of Inmagic Inc, USA. Do you have a software product you think has marketable properties? Perhaps you are a user of Inmagic or another system and have wondered about the view from the other side of the fence. This is your chance to hear from a pioneer in the field, someone who took an in-house tool and transformed it to the Inmagic product we know today. Elizabeth's keynote address is titled: "On the Edge of the Millennium - Looking Into the Future: From Information Managers to Information Leaders."

Joanne Gard Marshall is the Associate Professor of the Faculty of Information Studies at the University of Toronto, Canada A boundary bender whose skills and experience have much to offer special and health librarians, she has been

very active in both the US Special Libraries Association (SLA) and the US Medical Library Association (MLA). She has combined a career as an educator, a practitioner and a researcher. Special librarians would be interested in the work Joanne has done as chair of the SLA Committee on Competencies for Special Librarians of the 21st Century, or perhaps her report on "The Impact of the Special Library on Corporate Decision Making". Health librarians would know her Rochester Study - "The Impact of the Hospital Library on Clinical Decision Making" which was published in the Bulletin of the Medical Library Association in April 1992, a study which won the 1993 Eliot Prize from the MLA and is a citation with a considerable impact factor of its own. She is currently chairing the Implementation Task Force for the MLA Research Policy Statement "Using Scientific Evidence to Improve Information Practice". Joanne's keynote address is titled: "Creating a Vision for the 21st Century: the Way Ahead for Library and Information Professionals."

Another five speakers from overseas and over 70 Australian librarians will give us the benefit of their experience, research and thoughts.

Supreme Court of New South Wales: Use of unreported judgments available electronically

Following a request from the Director of Public Prosecutions to use electronic printouts of unreported judgments in the Supreme Court of New South Wales, the Law Foundation of NSW has had a series of discussions with the Chief Justice, the Hon Murray Gleeson AC. As a result of these discussions, the following position has been reached:

The Supreme Court of NSW recognises that unreported decisions of a number of Australian Courts are available electronically on the Internet, through the Foundation Law and AustLII web sites, the web sites of commercial publishers, and on CD-ROM services

On the 17th April 1997, the Chief Justice of the Supreme Court of New South Wales has approved the use, in that Court, of printouts of unreported judgments of:

The Supreme Courts of Australian States and Territories;

The Federal Court of Australia;

The High Court of Australia

Note that this approval is limited to printouts of unreported judgments Use of computer printouts for judgments which are reported in the Law Reports is an impermissible practice

JURIST collects law professors' Web-based home pages, course pages, resource pages and online articles (both "pre-prints" and "post-prints") and, for the first time, makes them conveniently accessible to other law professors, lawyers, and law students, as well as to the public at large

JURIST also offers listings for the Web sites of major professional and legal associations, directories of law review and law school home pages, pointers to law listservs, access to a law-dedicated search engine, and last (and, perhaps until this part is absolutely finished, least!) direct e-mail connections to other legal academics in the US and abroad.

JURIST is continually under development, so updated information and suggestions for new links are very welcome! General comments on this still somewhat experimental service would be especially appreciated

As some of you may recall, the latter piece argued that legal scholars should take control of their own work by moving away from traditional law review publication towards a system in which self-published Web-posted articles would be centrally archived (or hyperlinked) and made available for post-hoc open peer commentary
