A new file called *90DAYS* has been added to the *NEWS* library This file contains the same sources as *CURNWS* but only includes articles from the last 90 days instead of two years.

The Canberra Times is now available from 14 July 1997 It is available in the *ASIAPC*, *AUST*, *NEWS* and *WORLD* libraries in the file *CANBER*.

Two intellectual property sources have been added recently to the *PATENT* library. Baxter World Patent Law in the file *BAXPAL* describes the complete patent process, from filing to grant, for all industrialized nations Intellectual Property Today in the file *INTDAY* is a monthly magazine which focuses on legal intellectual property issues.



UK Official Documents

This site has been expanded and now includes the full text of other parliamentary documents as well as Acts and Statutory Instruments since 1996 and Bills

Selected Command Papers, Green and White Papers and Consultative Documents are now available in full text House of Lords debates are available from 10 June 1996; and for the House of Commons the five most recent days debates are available. Orders papers since October 1996 are included Select Committee Reports are available from both the Hose of Lords and the House of Commons

House of Lords Judgments since 14 November 1996 are included; and the site now includes Judgments of the Lord Chancellor's Department

Other information available includes press releases from government departments and from Select Committees of both houses. There is also a Weekly Information Bulletin which includes information on bills before parliament and their progress and Business of the House of Lords and House of Commons for the coming week.

Environmental Treaties and Resource Indicators

Entri is a collection of over 170 international environmental treaties and national resource indicators. The treaties are organised into nine issues areas which include land use, climate change, ozone depletion, air pollution, biodiversity, deforestation, the oceans, trade and the environment and population. Treaties can be browsed in alphabetical or chronological order or searched for by keyword. They can also be searched by seven basic questions, including date of entry into force, subject and country.

Legal Journals on the Internet

The Flinders University Law Library annotated list of Legal Journals on the Internet has just been updated and now includes links to over 180 legal journals. The list is divided into full text legal journals, and those with abastracts or contents pages only.

Search Engines

Northern Light is a fast new search engine which in addition to searching the web searches 1800 full text journals, reviews books, magazines and news wires containing approximately one million articles. Some law journals are available, including the American Business Law review and the Yale Law Journal Abstracts are provided free; and the full article can be purchased for between US\$1-4 Each week, articles from a selected journal are made available free.

An interesting feature of Northern Light is that it groups search results into custom query folders on the left hand side of the screen. Depending on the topic of the search, these folders may be of four kinds: subject, type of document, source eg commercial or educational web site and language For a query on feminist jurisprudence, my results were grouped into ten folders, including feminist theory, feminism, law, international law, educational sites and personal pages. A disadvantage is that it does not yet support full boolean searching; although you can use or and **not**. A + symbol before a word indicates that it must be present in the search results; and a symbol that it must not.
