National Executive Committee Meeting

The ALLG recognises the importance of developing and maintaining a strong national identity This is a demanding process given that the Committee membership changes regularly and

the Committee meets only once each year Email has made communication easier. National Committee members receive regular updates and provide feedback as requested after consulting their state committees and members.

My experience of ALLG National Executive Committee meetings is entirely positive It is invigorating to sit down with a group of colleagues who all want to see the Group achieve its objectives and deliver benefits to its members This year's meeting, held during the Law Symposium in Melbourne in early October, was right on track. There was much progress to report on – projects from the web site redevelopment initiative, constitution review, conference scholarship programme and the selection criteria review, the conference programme for 1999 and 2000 and developments with the *Australian Law Librarian*.

The possibility of organising a joint ALLG/NZLLG conference was discussed. Following preliminary input from **Jane Treadwell**, the NZLLG nominee, and consideration by the New South Wales State Division, it was decided that the ALLG will run a third Law Symposium in Sydney in 2000 I have written to the NZLLG explaining the reasons for the decision. The ALLG National Committee hopes that New Zealand law librarians will participate in the Symposium and looks forward to developing closer links between the two organisations

Future Directions

We are in the processing of revising our Constitution The Constitution sets out the Group's objectives in broad terms There is also a need for a document which expands on these objectives and sets out specific initiatives to achieve them. The American Association of Law Libraries has produced a report called *The Strategic Challenge 1998-2000* which identifies and defines a number of strategic directions and outlines an implementation plan. This report will provide a model for an ALLG document which will be prepared over the next few months and ratified at the Biennial General Meeting.

Biennial General Meeting

The format of the next meeting which will be held during the 8th Asian Specials, Health and Law conference in Hobart in August 1999 will allow greater scope for input from members. The agenda will include current projects, future initiatives and any other relevant topical issues. These changes to the structure of the meeting are in direct response to a request from the Tasmanian Division for a more open forum for discussion. Formal reports will be tabled and distributed with the Minutes.

International Conference Scholarship Selection Criteria

Selection Criteria Guidelines have been prepared for international conference scholarships. The document also covers the selection process. It can be adapted to suit awards of all kinds at both national and state levels.
