Time Base Puts Daily Legislation Online – Aunty Abha's Adopts New Name

Time Base Pty Ltd (incorporating Aunty Abha's Electronic Publishing) recently announced a new online strategy, which includes the daily update of consolidated legislation on the Internet. The new service will commence at the end of November 1998

At the same time the company announced it has changed its trading name to Time Base from Aunty Abha's Electronic Publishing, adopting the name of its parent company, Time Base Pty Ltd.

Each day, updated consolidated Commonwealth legislation will be posted at the Time Base Internet site If an amendment has been passed, that fact will be immediately noted at the site Then, the instant the Act or Regulation has been updated, the full consolidated legislation will be posted

In the near future, the Time Base site will also include weekly updates of the New South Wales legislation, and by early 1999 all five jurisdictions will be available on the website Currency and amendment information will be available, as will other value added features such as numerical lists of all legislation. The site will also include the Federal Cases product.

The online Internet service is free to all customers who subscribe to ten CD-ROM updates per year Additionally, anyone can access the site to get currency and amendment information free.

Every product previously published under the Aunty Abha's name will continue to be published by Time Base. The only change will be the name of the company and the increasing number of products available. There is no change of ownership

Time Base is a 100% Australian owned and operated company, and is currently using a Commonwealth Government R&D grant to develop the electronic publishing technology of the future

Butterworths Australia and Folio 4

Folio 4 2 is the latest version of Folio Views. It has many new features and improvements on Folio 3 x, the version currently being used by most publishers in Australia. The most significant new features include faster searching, a customisable interface, the introduction of a hit list, and the ability to easily search beyond the 'record' structure on which Folio Views is based

Why then has it not yet been implemented in Australia?

The first reason is a peculiarity of the Australian legal environment – the number of Mac computers in use. There are a significant number of legal organisations in Australia which use Macs Folio at first was not going to even bring out a Mac version because there is simply no demand in the USA. After we applied a great deal of pressure on them, Folio agreed to create a Mac version of Views 4.2. This Mac version has only recently been released.

The second reason for not rushing in to upgrade our users to Folio Views 4 2 is that it looks and works quite significantly differently to the existing version. We have been planning very carefully how to go about upgrading our users from version 3 to version 4 with the absolute minimum of disruption. We know how much our users rely on access to our publications and take this issue of a major upgrade very, very seriously. To this end we have been undertaking extensive

internal testing and have made contact with our competitor publishers to ensure that nothing we do will conflict with the way they implement Folio 4

The transition to Folio 4 will of necessity be a slow, careful process which we will undertake in close consultation with users - and so it will be many months yet before our users see Folio 4 on their desktops

BigEar is a service of the Cornell Law School BigEar listens to a variety of law-related mailing lists and newsgroups From each, it selects messages which contain references to Internet documents, and constructs a convenient cumulative listing which shows the title of the document, a link to it, and a link to the message "announcing" it on the mailing list. At the end of each week, the old listing is archived and a new one started. It thus offers one view of what's new on the Internet for lawyers

Preserving Digital Information

Preserving digital information is one of the great challenges facing librarians and archivists There are numerous issues that must be addressed, from technical details to organisational structures. In this article Kranch focuses primarily on the technical details, by putting forward the idea of encapsulating digital content in a 'tablet' that contains all the hardware and software required to use it. Such tablets would, presumably, prevent the need to migrate the information forward into new systems that replace the ones used to create the information in the first place Although the idea has some merit, one could just as easily consider the information to be 'entombed' as well as preserved, since presumably it would not be accessible to any future systems that add capabilities to the manipulation of digital information Nonetheless, we are too early in the digital preservation game to throw out any ideas too hastily. At this point every idea should receive serious and thoughtful consideration
