Searching can be performed by several methods:

- · by keyword or patent number
- · boolean and advanced techniques
- · full text in natural language

Print and CD-ROM copies of patents can be ordered but naturally, a fee is incurred at this stage.



Hague Conventions are the result of work by the Hague Convention on Private International Law. They include international instruments such as:

- Convention on the Recognition and Enforcement of Foreign Judgments in Civil and Commercial Matters
- Convention on the Taking of Evidence Abroad in Civil and Commercial Matters
- Convention on the Civil Aspects of International Child Abduction

The Hague Conference began in 1893 and is a permanent intergovernmental organisation that aims to unify the rules of private international law. Since 1955, the Conference has met every 4 years. The 18th session was held in 1996. There are 46 member states, of which Australia is one.

The Hague Conference site includes the following information:

- Full text of all Conventions
- Explanatory reports for selected Conventions
- Status reports for all Conventions outlining the member states that have accepted the Convention and any reservations
- An extensive bibliography of material relating to each Convention.
