It currently covers Commonwealth, New South Wales and Victorian legislation from 1997 although there are plans to add retrospective information for the past decade. No costing is available yet.

At the time of writing, updating had been performed within a week. A value added service is extended to users, who can subscribe for email notification of new additions to the site.

Unfortunately, the reports are contained in one very large (2 5 MB) Word document, making downloading very time consuming. The reports are not searchable, although there is a table of cases and subject index. The table of cases and index is provided as a separate Word document and does not have hyperlinks to the full text of cases. Other information available at the Workcover site includes - premium simulators, information for employees, employers, doctors and lawyers, information about hazard prevention, and a government position paper about changes to workers compensation laws.

Explanatory Notes for UK Bills


