## RAAF takes big consignment to Kiribati

On Sunday, 9 May 1999, the RAAF freighted 79 boxes of law books donated by the BHP Library in Melbourne to the High Court of Kiribati The consignment included Australian Law Reports, Victorian Law Reports, and Commonwealth and New South Wales statutes Arrangements for the despatch of this large gift were quite complex and preparing the boxes for collection involved measuring and weighing every single box, as well as filling out customs export forms following 15 pages of notes A convoy of three cars transported the boxes from the High Court to the RAAF Base at Fairbairn in Canberra ready for uplift to Richmond, NSW. With the help of the RAAF personnel, it was all completed on time to

catch the Hercules leaving on 9 May. I would like to thank the RAAF for their marvellous assistance to the ALLG Pacific Twinning Program, and their cheerful cooperation in helping us send the consignment. Many thanks also to BHP Library for their most generous gift.

The RAAF has forms available to make a 'Request for Non-Emergency Defence Assistance to the Civil Community'. The Program may be able to call on their assistance again as Air Force personnel have to make a stop in one of the Pacific countries on their way to the United States.
