A November appeal on the anz list for twin libraries to assist in providing material for two law libraries in Fiji met a warm response from several of our colleagues. The result was that a week later there were two very happy law librarians in Suva. The new twins are:

- 1. Institute of Justice and Applied Legal Studies, USP, Suva (librarian: Ethel Morris) twinned with CBA Legal Department Library, Sydney (librarian: Barbara Ferris); and
- Attorney-General's Library, Suva (librarian: Meena Shandil) twinned with ACT Government Law Library (librarian: Julia Butler)

The response of both Fijian librarians to the news that twins have been found for them highlighted the value of the ALLG Twinning Programme to the Pacific libraries. One library has only 700 books and in the other case the budget allows for the purchase of only 5 new books per year Both librarians expressed their gratitude to the Australians who have offered to help them.
