

Copyright Amendment (Digital Agenda) Bill 2000

The Copyright Amendment (Digital Agenda) Bill 2000 was finally passed in the House of Representatives in July. It is now before the Senate and by the time you read this it will possibly have passed the Senate as well.

GST and the ALLG

The National Executive Committee of the ALLG has applied for and received its ABN. The other sections that have applied are the NSW Division, the Western Australian Division, the 2000 Symposium, and the Australian Law Librarian. Each Division has the option of

applying for an ABN but is not required to do so. The National Executive Committee is in the process of investigating GST management packages with a view to purchasing one for all divisions to use as needed
