I am presently acting for a woman whose intellectually retarded 15 year old daughter was placed in the care of the Queensland Department of Family Services.

It appears, and it is our client's allegation, that while her daughter was in the care of the Department her daughter was allowed to travel away from her foster carer with two other girls and three older men. At least one of the men appears to have been previously convicted of sex offences. Whilst in the company of these men our client was abused by one of the men.

We have a client who underwent an anterior spinal fusion from C3 to C6 in May 1993 using the material known as synthes plating. Shortly thereafter the upper fixation screws migrated through the C2/3 disc space to lodge in a position in the middle of the C2 vertebral body. We have been told by another solicitor that the operating surgeon has reported other incidents in which this has occurred. There are also other incidents currently awaiting litigation where this material, when used for fusions, has broken.

My client was injured on 30.10.91 in Victoria in the course of employment. He was absent from work for several weeks and then returned to active employment. In 1994 his condition deteriorated and he has now undergone numerous surgical procedures to his spine.

For common law purposes I requested and received a serious injury certificate from the WorkCover insurer, settled several Section 98 claims and then issued common law proceedings. The defendant insurer's solicitors are now alleging that the provision of the serious injury certificate "was not intended and was a slip".

The facts of the matter involve a partial head on collision with another vehicle and my client's vehicle being a 1984 Toyota Tarago van. This was driven by the plaintiff. Upon impact the van, after one very short moment, exploded into flames. There were several deaths involved whilst others were very badly burnt. It was noted that the off side rear caution bar mount had severed on impact and punched through the upper area of the fuel tank. It is considered that this has caused the explosion.

We are seeking comment from any practitioners who may have had occasion to consider a vehicle defect claim in this nature.


