

# ABORIGINAL LAW BULLETIN

Issue No. 12 is rescheduled for December - deadline mid-November.

#### RESEARCH

The A.L.R.U. application to the Australian Research Grants Scheme (ARGS) for funds to support a 1985 research project on Aboriginal Land Rights Law in South Australia has not been successful. ARGS did fund a study of Aboriginal Land Rights Law in the Northern Territory which is nearing completion.

There is another application for funds awaiting determination which, if successful, would permit work to proceed on Land Rights Law in South Australia and in other jurisdictions.

Meredith Wilkie's study of Aboriginal Land Rights Law in N.S.W. (supported by the Law Foundation of N.S.W.) will be published at the end of this year or early in 1985.
