

I was on study leave between September 1986 - February 1987 working on issues relating to human rights and the rights of indigenous peoples.

I spent time in the United States, Canada, England, France and Switzerland. In Canada I sought up-to-date information on developments. In the USA I made contact with a number of organizations and individuals. In London and Geneva I contacted organizations and individuals involved in indigenous rights issues. Visit by Hon. Thomas Berger

Hon. Thomas Berger was chief Counsel in Calder ν Attorney-General of British Columbia (1973) SCR 313, the case which forced the Canadian Trudeau Government to take Indian claims more seriously. He was also Commissioner of an Inquiry into the social, economic and environmental impact of a pipeline in Northern Canada - the Mackenzie Valley Pipeline Inquiry. Commissioner he insisted that Indian opponents to the pipeline be funded to prepare their arguments. Recently he published a Village Journey. Report of the Alaska Native Review Commission, Hill & Wang, NY, (1985).

During May and June of this year Berger will be visiting Australia at the invitation of the Centre for Resource and Environmental Studies (CRES). will be speaking at the UNSW in May and several other places around Australia at other times. Visit by Dr Julian Burger

The Anti-Slavery Society for the Protection of Human Rights is based in It was founded in 1839 and is the world's oldest Brixton, London. Two years earlier, in 1837, the Aborigines humanrights organization. Protection Society was established. In 1909, it merged with the Anti-Slavery Society, and the Society still has a continuing function in regard to indigenous peoples issues.

1987 is the 150th anniversay of the establishment of the Aborigines Protection Society, and the 200th anniversary of the departure of the First Fleet from Britain. Dr Julian Burger of the Society will visit Australia for six weeks between April May to visit Aboriginal communities and others and to report on the current position of Aboriginal people in Australia.
