Finally, the book contains numerous biographical entries covering a wide variety of British and foreign judges and legal scholars. These include Australians Isaacs, Griffith, Dixon and Barwick, but surprisingly not Evatt, one of our most eminent jurists, whose work on *The King and His Dominion Governors* (Oxford, 1936) should alone have qualified him for inclusion.

To sum up, considering that the three comparable legal source-books, *Jowitt*, *Stroud*, and *Words and Phrases Legally Defined*, are all multivolume dictionaries, Professor Walker has provided a unique reference work. It is particularly useful in combining compactness with the extra encyclopaedic dimension that has till now been unavailable. Despite reservations concerning the Australian content, the book is a remarkable and scholarly contribution to legal reference.
