Submission of Manuscripts

In preparing articles for submission authors should be guided by the following points:

1. Please submit either two typewritten, double spaced copies or one copy on disk and one typewritten, double spaced copy. The disc should be either 3 1/2" or 5 1/4" in Macintosh or MS-DOS Microsoft Word, WordPerfect or plain text formats.
2. Authors are expected to check the accuracy of all references in the MS before submissions. It is not usually possible to submit proofs for correction.
3. Biographical Details should be starred (*) and precede the footnotes. They should include the author's full name, academic qualifications, and current employment.
4. Abbreviations should appear as follows: n3, p4, pp55. Full stops are not used to indicate abbreviations and it is not necessary to space an abbreviation and a number.
5. Footnotes should be numbered consecutively throughout, and should appear at the foot of each page or at the end of the text. All bibliographical details, case citations and similar matter should appear in the footnotes.
6. References and Citations
 - a. *Cases*
 - The full citation of a case should always be used when a case is first mentioned. The names of the first plaintiff and first defendant are set out in italics separated by a "v", followed by the Year, Volume Number, Abbreviated Name of Reporter, and Page Number (without p), eg *University of Wollongong v Metwally* (1984) 158 CLR 447. Do not include *Ors, Anor, The State of, City Council of* etc.
 - An abbreviated title may be used for frequent subsequent references, eg *Metwally's Case*.
 - Page references other than to the initial page in reports are preceded by 'at', eg *University of Wollongong v Metwally* (1984) 158 CLR 447 at 449, 451-453, 459ff.
 - b. *Books*
 - Bibliographic details should be cited in the following order: Author of Chapter or Essay, Title of Chapter or Essay, Author or Editor of Book, Title of Book (in italics), Volume Number, then in brackets - Publisher, Place of Publication, Edition (if not first) and Year of Publication - close brackets, Page Number(s).
eg Ratnapala, "What is Law?" in Corkery (ed), *A Career in the Law* (Federation Press, Sydney, 2nd ed 1990) p11.
 - First names or initials of authors should be omitted, unless confusion may arise.
 - c. *Journal Articles*
 - Bibliographic details should be cited in the order of Author, Title of article, Year and Volume Number, Title of Journal (in italics) and Page Number(s) (without p) eg Ligertwood, "The Evidentiary Bray" (1980) 7 *Adel LR* 176.
 - Periodicals should be abbreviated according to the suggested form appearing in their title page.
 - d. *Statutes*
 - The initial reference to a statute should be to Short Title (in italics), Year of Enactment, Jurisdiction (in brackets), and Section Number(s) eg *Sale of Human Blood Act 1962* (SA) s5, ss8-10.
 - e. *Subsequent references*
 - Use of *ibid*, *op cit*, *loc cit*, *supra* and *infra* is to be avoided. Where the footnote refers to the same source as the immediately preceding footnote a simple page reference suffices, eg At p13.
 - Where a case reference is repeated the subsequent reference should be to its short title and if a particular page is referred to that page stated (even if the page is repeated) eg *Metwally's Case* at 449, 451-453, 459ff.

- Where a book reference is repeated, the full name of the author and book should be repeated but publishing details omitted.
 - Where a journal article reference is repeated, the full name of the author, title and journal should be repeated.
 - Where a statute is repeated full details should be repeated, eg *Sale of Human Blood Act 1962 (SA) s6*. Where successive footnotes refer to sections of the one Act section numbers only may be used without repetition of the name of the Act, eg Ss7 and 8.
 - Where a previous footnote is repeated without alteration, it is necessary to state simply "As above" with the previous footnote number, eg As above, fn 23.
7. Double quotation marks should be used for direct quotations and single quotation marks for quoted quotations. Quotations of more than three lines should be indented and do not require quotation marks.
 8. It is the Association's policy to use gender neutral language. The third person plural used as singular should be used in place of the third person gender specific, eg they or their instead of he/she or his/her unless specific reference to gender is required.
