Other community legal education activities included free divorce classes held in Darwin, Casuarina and Palmerston by the NT Legal Aid Commission. Darwin Community Legal Service hosted free information sessions on Duty of Care and Discrimination Law in Tennant Creek and Alice Springs. The Central Australian Aboriginal Family Legal Unit (CAAFLU) and the Domestic Violence legal service jointly hosted a Domestic Violence Mock Court in Alice Springs. Magistrate Melanie Little provided information to school children in Kalkaringi and Lajamanu while on circuit court.
