### **Notes on contributors**

#### ***Joshua Burns***

After graduating with a Bachelor of Applied Science (Podiatry), First Class Honours and the University Medal, Joshua Burns has worked as a clinical podiatrist with a special interest in foot/ankle injury management, high-risk foot care and neuromuscular rehabilitation of the lower limb.
