

## **Chapter 18**

# **Indonesia's national and local Ombudsman reforms: Salvaging a failed experiment?**

The reality that corruption remains rampant in Indonesia was highlighted recently when debate surfaced over whether the President should declare an emergency state of corruption,<sup>1</sup> particularly in light of endemic judicial corruption.<sup>2</sup> Indeed, since the transition to democracy in 1998, the widespread problem of corruption has come under increasing scrutiny. This has led to the development of legal initiatives to combat corruption that focus on the goal of ‘good governance’, a term I define later. One of the first initiatives that was established in this atmosphere of ‘good governance’ reform was the National Ombudsman.

The Ombudsman is certainly a notable focus of democratic reform in Indonesia, which is now one of more than 130 other countries worldwide that have established such an agency (Komisi Ombudsman Nasional, 2005a: 12) but is the Ombudsman in Indonesia working effectively in practice? Has the Ombudsman addressed the widespread problem of corruption by promoting ‘good governance’ in Indonesia as hoped?

Furthermore, in light of the radical decentralisation reforms and the allocation of greater powers to regional governments, it is especially necessary to ask how the concept of the Ombudsman has developed and is working at the local level. Does the Ombudsman have sufficient powers of investigation and enforcement to fulfil its role effectively? What is the nature of the relationship between the Local Ombudsman and local authorities, the judiciary and the National Ombudsman? How has local support influenced the effectiveness of the Ombudsman in fostering good governance?

To answer these questions, this chapter will focus on the Local Ombudsman (Lembaga Ombudsman Daerah) in the Special Province of Yogyakarta, arguing that although the National Ombudsman is failing due to a decline in political support, the Local Ombudsman in Yogyakarta has been able to effectively promote good governance because of overwhelming local support. The efficiency and impact

creation of a Law in regard to the Local Ombudsman would further solidify these powers. The second element, the effectiveness of the Local Ombudsman's powers of enforcement (which are only morally, but not legally, binding) must continue to be monitored.

The success of the Local Ombudsman's investigations in instances such as the CDMA case has been secured by the good relationships the Local Ombudsman has built up with local authorities, namely the local government, the media and civil society. However, the existence of the Private Ombudsman must be re-examined, and positive steps must be taken to ensure the clear separation of powers between the Local Ombudsman and the judiciary. Clarification of the relationship between the Local Ombudsman and the National Ombudsman branch is also required, and the separation of their respective powers must be strictly maintained.

In light of the recent success of the Local Ombudsman in Yogyakarta, greater efforts should be channelled into the expansion of the office of the Ombudsman across Indonesia. This process should be focused on building local support as one of the key ways to effectively address corruption and foster good governance. Such measures will play an important part, alongside other steps towards good governance reform, in addressing the present alarming state of corruption in Indonesia.
