Dr Steven Angelides is a Monash Fellow in the School of Political and Social Inquiry at Monash University. He is the author of *A History of Bisexuality* (Chicago: University of Chicago Press, 2001), and a recipient of the American Modern Language Association's (MLA) Crompton-Noll Award for his research on child sexuality. He is currently completing a book on moral panics around child sexuality.

Dr Alan Berman is an Adjunct Research Fellow of the Socio-Legal Research Centre of Griffith Law School and Senior Lecturer in Law at the University of Newcastle School of Law. He has taught mostly in the areas of International Human Rights Law and Australian Constitutional Law. He has always had an interest in the connection between societal homophobia and hate crimes.
