Peter Auer holds a PhD in economics and the social sciences. He was chief of the employment analysis and research unit of the Employment Sector, ILO, Geneva and is at present senior fellow of the International Institute for Labour Studies of the ILO. He lectured at the Free University of Berlin, the University of Paris, Cornell University and the University of Sydney.

Marian Baird is the Professor of Employment Relations and the Director of the Women and Work Research Group at the University of Sydney Business School.
