

Editor's Notes

As with the first volume, the editors acknowledge, first, the contributions of each of the authors of the essays in this book. Once again, we should note the approach to the standardisation of referencing. Different authors have, for good reason, preferred different editions for certain texts (such as Glanvill); and in other cases an author's work may have been published many times in different forms or collections (such as the work of Maitland). While not perfect, the approach in this volume has been to provide a standard reference to selected texts at the outset, but within each essay to keep the full reference the first time a book or article is referred to, with subsequent ones taking a standard abbreviation of the author's name, and a contraction of the title.
