Margaret Allars is a Senior Counsel of the New South Wales Bar and holds a fractional personal chair in the Faculty of Law, University of Sydney, where she teaches postgraduate courses in administrative law.

Mark Costello was an associate to Justice Callinan of the High Court of Australia for two years and then worked as a solicitor at Arnold Bloch Leibler and Minter Ellison. At the Victorian Bar he practises in a wide variety of areas, principally commercial law, equity and public law.

Dennis Davis was appointed as a judge of the Western Cape High Court in 1998. In 2000 he was appointed President of the Competition Appeal Court. He is also a member of the Commission of Enquiry into the Tax Structure of South Africa. Since his appointment to the bench, he has continued to teach constitutional law and tax law at University of Cape Town where he is an Honorary Professor of Law. He has been a visiting lecturer/professor at many universities, including Cambridge, Florida, Harvard, Toronto and New York University. He is also a prolific author, including of books ranging from insurance law to detention and torture in South Africa, to rights and the South African Constitution.

Kathleen Foley is a member of the Victorian Bar. She practises primarily in public law and commercial law. A former associate to Justice Hayne of the High Court of Australia, she completed a Master of Laws at Harvard and practised as an attorney in New York before coming to the Bar in 2009.

Justin Gleeson SC is the Solicitor-General of the Commonwealth of Australia. He was formerly a barrister practising at the New South Wales Bar. His publications include many articles and *Rediscovering Rhetoric: Law, Language and the Practice of Persuasion* (Federation Press, 2008) (editor, with RCA Higgins) and *Constituting Law: Legal Argument and Social Values* (Federation Press, 2011) (editor, with RCA Higgins), as well as co-editor of *Historical Foundations of Australian Law* (Federation Press, 2013, 2 vols).

William Gummow AC is a former Justice of the High Court of Australia. Following his retirement he has been appointed to the Court of Final Appeal of Hong Kong as a non-permanent judge from another common law jurisdiction. He has also been appointed a professor at the Sydney Law School and in the ANU College of Law.

In April 2015 she was appointed Crown Counsel for the State of Victoria. Employment and industrial law has been the mainstay of her practice as a barrister, but also extends into many other areas including public law, equal opportunity and human rights, and personal injuries. She also worked as counsel assisting several public inquiries, including the 2009 Victorian Bushfires Royal Commission.

Alan Robertson is a judge of the Federal Court of Australia based in Sydney. Justice Robertson moved to the private Bar in Sydney in 1983, reading with WMC Gummow. He was appointed Senior Counsel for New South Wales in 1995. At the Bar, Justice Robertson practised mainly in public law, including constitutional law, administrative law and revenue law. He was a part-time member of the Administrative Review Council from 1992 to 1997. Justice Robertson was the convenor of the Administrative Law Section of the NSW Bar Association from 1995 to

2008 and convenor of the Constitutional and Administrative Law Section from 2008 to 2011. From 1988 to 2006, Justice Robertson was a member of the Administrative Law Committee, Law Council of Australia. From 1987 to 2009, he was the Consultant Editor of the CCH *High Court and Federal Court Practice* and, from 1997 to 2009, he was Consultant Editor of CCH's *Administrative Appeals Tribunal Handbook*.
