Marcelle has over 20 years' experience in the field of Indigenous peoples and laws, both as a lawyer and academic. Her research interests include the recognition of First Nations in international and domestic laws and Indigenous knowledges in legal education. She teaches in the units *Indigenous Peoples and Law*, and *Law in Context*. Marcelle is a member of the National Indigenous Research and Knowledges Network and is currently Project Leader for the Indigenous Cultural Competency for Legal Academics Program, funded by the Australian Government Department of Education and Training.

Russell Cavanagh is an Aboriginal Field Officer at the Port Macquarie Legal Aid Office on the Mid North Coast of New South Wales.
