Medical examinations

I act for a plaintiff who was involved in a motor vehicle accident some years ago, when, as a minor, she was struck by a bus.

The solicitors for the defendant required the plaintiff to undergo a psychiatric evaluation.

When our client attended a psychiatrist in Brisbane in December 1997 she was required to sign two forms, the nature of which were not fully explained to her.

During the course of the evaluation our client was told by the psychiatrist that he required her to have blood testing done to find out whether she was on any form of drugs. My client was given little or no opportunity to object to this. When she attempted to do so, the psychiatrist said, "It is better for everyone if we do this". Our client then said (words to the effect) "How come none of the people I has seen before have done this?" To which the psychiatrist said, "They are not doctors. I am a doctor. I am a physician." The lady in question then sought to telephone my office but was simply not given the opportunity to do so. To add to the indignity, the psychiatrist then asked to see where on her body the blood testing had taken place.

Although I acknowledge that the lady in question probably technically consented to this procedure, she did no know what she was consenting to at the time.

Further, there was a clear power imbalance. The lady in question, although intelligent, did not know the law or her rights and felt that she was not in a position to object.
