APLA National President, Dr. Peter Cashman, delivered an emotional recounting of the ordeals that each of these three women have been through and the persistence they have shown in pursuing rights and entitlements, which have resulted in changes to the law that are favourable to all Plaintiffs.

The National Conference dinner closed with a rock band belting out some dance classics including "You can leave your hat on", which managed to lure four Plaintiff Lawyers up onto the stage to do a nearly full monty.

While the Sydney conference provided some undoubted advantages it did lose some of the communal feel generated by the previous conferences at the Queensland Resorts.
