The keynote speech on 'Access to Justice' was presented by His Honour Justice Moynihan, Senior Judge Administrator of the Queensland Supreme Court. His Honour's comments, together with an interview of Steve Roche, President of APLA Queensland, gained coverage in the Weekend Australian.

The APLA Queensland Civil Justice Award was presented by Steve Roche to Arnotts Limited for its excellent work in Workplace Health and Safety and Rehabilitation. Since Arnotts became a self-insurer for workers compensation they have not had a single common law claim against them, and have introduced successful injury reduction and rehabilitation programs.
