May I also take this opportunity to record my personal gratitude, and that of the courts, to Justice Glenn Martin who has been instrumental in organizing the splendid building opening ceremony which occurred yesterday, this

As part of that history, Justice White reminded me yesterday that Sir Samuel Griffith, our legendary Queensland jurist, was appointed Attorney-General on 3 August 1874. I venture he would have been immensely proud of the achievement we celebrated on his anniversary yesterday.

We have included biographies in the seminar programme booklet so that they need not be rehearsed.
