Firth, of Geelong, editor of *The Summons*, 1893-4, and to receive some interesting reminiscences from Mr. F. C. Purbrick, of Wangaratta, who was secretary of the Society from 1894 for two or three years, succeeding Mr. W. F. Weigall, who followed Mr. H. E. Starke (now Mr. Justice Starke) in that office.

In regard to *The Summons*, Mr. C. J. Ahern, one of the first sub-editors, has kindly drawn our attention to the fact we were in error in stating that the first editor was Mr. William Brockett. Mr. Brockett was editor at a later period, but the first editor was F. J. Tucker. *The Summons* has gained further lustre by reason of the fact that Sir Frank Gavan Duffy's "Dream of Fair Judges" was first published in its pages. It may be of interest to former members to know that a complete set of *The Summons*, from 1891 to 1903, is available at the Public Library, Melbourne.

Next year the Society will be celebrating its 50th anniversary. It hopes to do so, with what grace it can, by holding a dinner and by arranging special addresses and meetings, to which old members will be very welcome. It is also intended to publish a special number of *Res Judicatae*, containing articles of an historical interest, reminiscences, and the like. We should be very pleased to hear from former members who would assist us in this.
